RE-ELECTION OF RETIRING COUNCIL MEMBERS

The following members of Council, being eligible for re-election, stand for election to hold office for a second term of up to 3 years (until the 2028 AGM):

James Allan

James brings extensive skills in youth development and volunteering strategy and a close connection to the Scottish boating community. Formerly chief executive officer for RYA Scotland, he was responsible for developing and delivering boating programmes and opportunities for some 270 clubs, training centres and affiliated organisations across Scotland. Previously, he has been a youth services and learning and development manager at a local council, as well as programme and development executive for the Scottish Scout Association. James is an active sailor, windsurfer and RYA Advanced Powerboat Instructor. He has held various volunteer roles in boating and was previously a scout leader and non-executive director and treasurer for Mountain Training Scotland. He lives in Argyll and Bute.

Simon Bowen

Simon is an experienced business operations executive and non-executive, specialising in engineering and health and safety leadership. His last executive role was chief executive

(nuclear) at Babcock International, where he led on safety across the Babcock Group, as well as the company's nuclear activities in the civil and defence sectors. He has remained as the Chair of Devonport Royal Dockvard, a nuclear licensed company. Simon is a fellow of the Royal Academy of Engineering and spent his career in multiple sectors including nuclear, petrochemicals and defence. In May 2022 he was appointed as the nuclear advisor to the Prime Minister and led the scoping phase for the setup of Great British Nuclear (GBN), the organisation established to deliver the government's new nuclear programme. He is now the Interim Chair of the GBN. Simon serves on the RNLI Safety and Assurance, Engineering Assurance, and Engineering Special Interest Groups, as well as being Interim Chair of the Technical Committee, He lives in Swansea.
